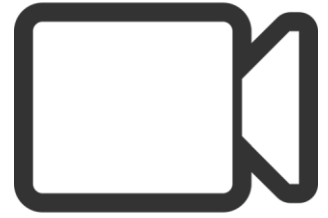

Homework Presentations - Small Group

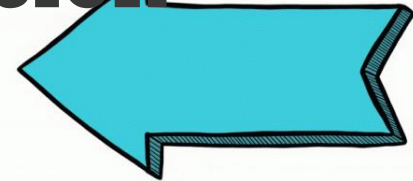
1. Bring 2-3 newer photographs. Select ones that reflect children's joyful learning. Write down your reflections:

Large Group Discussion

- 1. Presentation of Documentation:** The presenter describes and shares the documentation of the children's experiences through photos/video (without interruptions).
- 1. Get-to-Know-More Questions:** The Listening team then asks questions to the presenters to clarify their understanding of context or logistics.

Large Group Discussion



- **Probing/Deep Dive:** A discussion about the child's work and approaches –
 - What do you notice? What questions do you think the child/children have/had?
 - Why do you think the child/children are interested in this experience?
 - What do you wonder about?
- *Groups and Hub Team members discuss*
